Guiding Principles for College Early

Program Description

College Early is an opportunity for high school juniors and seniors to experience Pacific Union College's rigorous academic environment while earning course credit in lower division courses.

The College Early special tuition rate do not apply to Adventist Colleges Abroad, flight training courses, private music lessons, audited courses, or directed study courses.

In addition to applicable College Early tuition charges, there are established fees associated with certain courses (e.g. materials fees for Visual Arts courses). See the General Catalog for an overview of the current fee structure.

Please note: Because tuition for College Early is already at a reduced rate, PUC employee discounts for children of faculty and staff members do not apply.

Admissions Qualification

1. Current enrollment in grade 11 or 12
2. Minimum high school GPA of 3.0 after the most recent semester
3. Endorsement of the student by the academy Registrar or Principal as a qualified candidate for College Early
4. Consent of a parent or legal guardian

Enrollment Procedure

1. In consultation with the Office of the Academic Dean, the student's parent or legal guardian, and college instructors (if necessary), qualifying students may select up to 6 credit hours of lower division courses (numbers of 299 or below) from the College's course schedule to take at the reduced tuition rate (\$110 per credit) plus course fees. To check available courses, visit flashlight.puc.edu and select "Search for Sections" on the left.
2. This form must be signed by the student, the student's parent or legal guardian, and the high school registrar or principal (who will verify that the student meets the GPA requirement and any prerequisite requirements specified in PUC's *General Catalog*). Once completed, the form is to be emailed to PUC's Admissions Office: admissions@puc.edu
3. College Early students are enrolled in courses only once it is clear that there will be room in the class, or if there is no limit to class size.
4. After the student is registered, first-time enrollees will receive an email with their PUC Student ID number and instructions for setting up their PUC accounts: Webmail, Flashlight, and Canvas.
