### YELLOW RIBBON PROGRAM APPLICATION

**Note: Applications are not considered complete without a copy of the Certificate of Eligibility (COE), issued by the Department of Veterans Affairs (VA), stating that you are 100% eligible for this program. Yellow Ribbon consists of an institutional Yellow Ribbon award from PUC and a matching Yellow Ribbon award from the VA.**

Qualified applicants may receive up to the following award amounts (with a matching amount from the VA), once per academic year:

- **Undergraduate students:** Awards up to \$8000 of remaining unfunded tuition
- **Graduate students:** Awards up to \$8000 of remaining unfunded tuition

  - I served for at least 30 continuous days (all at once, without a break) on or after September 11, 2001, and was discharged after 60 days with a service-connected disability, or
  - I am a dependent child using benefits transferred by a Veteran or a service member who has served for at least 36 months on active duty and qualifies at the 100% level, or
  - I am a dependent spouse using benefits transferred by a Veteran, at the 100% level, and the service member is no longer on Active Duty.
- ☐ I understand that if I do not provide the Veterans Service Office at PUC with all proper documentation and follow policies and procedures, I will not be considered for the Yellow Ribbon Program.
- ☐ I understand that PUC only awards Yellow Ribbon in one term per academic year. This is awarded only during the term that I reach the VA annual tuition benefit cap.
- ☐ I understand that Pacific Union College is not required to continue making Yellow Ribbon Program contributions if I am not in good academic standing or if PUC does not renew the Yellow Ribbon agreement with the VA for the following academic year.
- ☐ I understand that if I have any outstanding VA overpayments with previously attended institutions of higher learning, I may be ineligible to receive Yellow Ribbon funding.
- ☐ I understand that upon confirmation of Yellow Ribbon eligibility, institutional need-based awards from the college may be adjusted.
