Section 3 - Hazards Identification

EMERGENCY OVERVIEW

Appearance: white to yellow white solid.

Warning! Causes respiratory tract irritation. Causes eye and skin irritation. Possible sensitizer.**Target Organs:** Respiratory system, eyes, skin.

Potential Health Effects

Eye: Causes eye irritation. May cause chemical conjunctivitis.**Skin:** Causes skin irritation. May cause skin sensitization, an allergic reaction, which becomes evident upon re-exposure to this material.**Ingestion:** May cause gastrointestinal irritation with nausea, vomiting and diarrhea. The toxicological properties of this substance have not been fully investigated.**Inhalation:** Causes respiratory tract irritation. May cause allergic respiratory reaction. The toxicological properties of this substance have not been fully investigated. Can produce delayed pulmonary edema.**Chronic:** Effects may be delayed.

Section 4 - First Aid Measures

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.**Skin:** Get medical aid.
