### Occupational Information

#### What can I do with this major?

Following graduation, students with this major often begin their career in one of the following:

- 1) Internships in church organizations, businesses, and pastoral ministry.
- 2) Graduate schools of business, denstry, law, medicine, or theology.
- 3) Self-employment.

Employment opportunities are available in a wide range of fields. Completing subsequent masters and doctoral degrees will increase opportunities and income levels.

#### Additional Education Required?

Many organizations require a bachelor's degree for potential employees. This bachelor's degree affords employment in both church and business organizations. Students seeking management roles may need to complete a master's degree and many organizations favor candidates with a doctorate.

#### Job Outlook

Church organizations increasingly look for candidates with both theological and business capacities while businesses pursue candidates with broader fields of study. By completing this degree, the student is qualified for entrance into either field, potentially doubling the prospects of employment.

The B.S. degree in Business Administration does not require a specialization within business and is often chosen by students pursuing professional graduate degree programs.

### How to Construct Your Own Program

1. Consult with your academic advisor.
2. Consider your aptitudes, interests, and available courses.
3. Schedule major courses and cognates first.
4. Fill the rest of your schedule with G.E. requirements.
5. For the freshman year include English, Religion, and PE courses. Also include Basic Algebra I+II unless waived by previous work.

### What the Degree Includes

A total of 192 quarter hours including:

1. A minimum of 60 upper division hours.
2. General Education requirements.
3. Major requirements.
4. Minimum 2.0 GPA, overall and major.
